#### **4. FIRST-AID MEASURES**

General advice: Consult a physician. Show this safety data sheet to the doctor in attendance. Move out of dangerous area.

If inhaled: Move person into fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Consult a physician.

In case of skin contact: Take off contaminated clothing and shoes immediately. Wash skin with soap and plenty of water. If open wounds, apply a topical antiseptic agent. Consult a physician. Wash contaminated clothing before reuse.

In case of eye contact: Immediately and thoroughly flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. If easy to do, remove contact lenses. Continue rinsing eyes and consult a physician.

If swallowed: Never give anything by mouth to an unconscious person. If conscious and alert, rinse mouth with water. Do not induce vomiting. Consult a physician or poison control center immediately.

Most important symptoms and effects, both acute and delayed: May irritate and cause redness and pain. Bacterial infection may occur through open wounds or broken skin. Nausea, vomiting or diarrhea may result from ingestion.

Treatment: Treat symptomatically. If any irritation or symptoms persists, seek medical attention immediately.

#### **5. FIRE-FIGHTING MEASURES**

Specific hazards that may develop from this product during fire: Hazardous decomposition and byproducts may include carbon oxides (such as carbon monoxide and carbon dioxide) and other unknown substances that may be toxic or irritating.

Suitable extinguishing media: Product is not flammable. Water spray, alcohol-resistant foam, dry chemical or carbon dioxide may be used for surrounding fires.

Advice for firefighters: Wear self-contained breathing apparatus and full protective clothing in case of fire.

Precautions for firefighters: Use water spray to keep fire-exposed containers cool.

General advice: Spilled product produces highly slippery surfaces.

#### **6. ACCIDENTAL RELEASE MEASURES**

Personal precautions, protective equipment and emergency procedures: Keep unnecessary personnel away. Wear appropriate protective equipment and clothing during clean-up. See section 8 for personal protection. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Local authorities should be advised if significant spillages cannot be contained.

#### Methods and materials for containment and cleanup procedures:

**Large Spills:** Stop the flow of material, if this is safe. Completely contain spilled material with dikes, sandbags, etc., where this is possible. Spilled material may be removed with a vacuum truck. Remaining material may be diluted with water, then absorbed and collected. Absorb spill with inert material (e.g., diatomite, dry sand or earth), then place in a chemical waste container. Following product recovery, flush area with water.

**Small Spills:** Absorb spill with vermiculite or other inert material. Clean surface thoroughly to remove residual contamination.

Spills will cause slippery surfaces. Never return spills in original containers for re-use. Keep in suitable, closed containers for disposal. For waste disposal, see Section 13 of the SDS.

**Environmental precautions:** Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground. Discharge into the environment must be avoided.

## **7. HANDLING AND STORAGE**

**Precautions for safe handling:** See Sections 2 and 8. Read the SDS and label carefully and completely before handling this product. Do not get in eyes or on clothing. Do not taste or swallow. Use only with adequate ventilation. Wear appropriate personal protective equipment. Transfer and storage systems should be compatible. Observe good hygiene practices. Do not eat, drink or smoke where the product is being used. Wash thoroughly after handling.

**Conditions for safe storage:** Keep only in original containers. Keep containers tightly closed, properly labeled and upright to prevent leakage. Store in a cool, dry, shaded and well-ventilated place away from sunlight and extreme temperatures. Store at temperatures between 55°F and 85°F. Containers which are opened must be carefully resealed. Do not mix with other chemicals.

## **8. EXPOSURE CONTROLS/PERSONAL PROTECTION**

**Appropriate engineering controls:** Provide sufficient mechanical ventilation.

**Personal Protective Equipment (PPE):**

**Eye Protection:** Wear chemical safety goggles with a face shield to protect against eye and skin contact when appropriate. Provide an emergency eye wash fountain and quick drench shower in the immediate work area.

**Skin and Body Protection:** With sensitive skin, open wounds or skin cuts, wear chemical resistant clothing and rubber boots when potential for contact with the material exists. Contaminated clothing should be removed, then discarded or laundered.

**Hand Protection:** With sensitive skin or cuts, wear appropriate impermeable, chemical-resistant gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product. Wash and dry hands after handling this product.

**Protective Material Types:** Natural rubber, Neoprene or Nitrile with minimum layer thickness of 0.11 mm and break through time of 480 minutes.

**Respiratory protection:** Local exhaust is generally sufficient to prevent overexposure. Where risk assessment shows air-purifying respirators are appropriate, use a full-face respirator with multipurpose combination (US) or

type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. A NIOSH approved respirator with N95 (dust, fume, mist) cartridges may be permissible under certain circumstances. If the respirator is the sole means of protection, use a full-face supplied air respirator. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU).
