PRECAUTIONARY STATEMENTS

Response/First Aid:

Biodegradable

This product is a concentrated blend of neutral air freshening ingredients which attack malodors right at their source. It can be used in any deodorization or odor neutralization application. It is safe to use in hotel rooms, restrooms, around dumpsters, garbage areas, docks, in carpeting or in any area that has offensive odors. It can be used with automatic dispensing equipment or sprayed directly in the area.

Application: Use as is or dilute up to 1:4 with water. Use directly on and around the source of odor by spraying, using a spray bottle, mist applicator or pump-up sprayer. Use will vary depending on the severity and concentration of the odor and on the sources of the malodor. Normal use will consist of 4-8 oz. per 1000 cu. ft. of air volume or 100 cu. ft. of dumpster volume, as frequently as needed. Apply in any area that has offensive odor. Consult your Arcot representative for proper dispenser set-up and training.

Spray directly on **carpet** to counteract malodors caused by spills, pet stains, mold, mildew or odor-causing bacteria. Work product into the carpet by brushing. Wait for one hour. Remove residues by wiping or vacuuming.

For deodorizing **rooms**, spray directly in the center of the room, working your way out.

For deodorizing **restrooms**, spray into, onto and around toilet bowls, urinal stands and trash cans.

For preventive maintenance of **garbage or dumpster areas**, spray or pump every 4-6 hours depending on the severity of malodors.

NOTE: Product causes surfaces to become slippery. To avoid slippery conditions, do not apply onto, over or around contact or traffic surfaces.
