### **PRECAUTIONARY STATEMENTS**

**Prevention:** Keep container tightly closed. Keep only in original container. Keep cool. Do not breathe mist, vapors or spray. Do not get in eyes, on skin, or on clothing. ### **Response/First Aid:**

**IF IN EYES:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. Immediately call a doctor or an ophthalmologist.  
**IF SWALLOWED:** Rinse mouth. Do NOT induce vomiting. Get medical attention if you feel unwell.  
**IF ON SKIN (or hair):** Wash with plenty of water. Take off immediately all contaminated clothing and wash it before reuse.  
**IF INHALED:** Remove person to fresh air and keep comfortable for breathing. Call a doctor if you feel unwell.

It restores the fabric life that detergents, breaks and bleaches take out, giving fabrics that fresh soft feel and smell.

**Application:** Read Safety Data Sheet Carefully Before Handling. Wear impermeable gloves. Wear safety glasses if splashing or eye contact is possible. Always follow washing instructions on the machine and the clothing. The recommended starting amount is 1 oz. (30cc) per 10 Lb. load of clothes or 1/2 oz. (15cc) per gallon of rinse water. Adjust use level as needed. Always pour into rinse water. Spotting may occur if product is poured directly onto dry or damp fabric. To obtain best results, consult your Arcot representative.

Do not use this product on silk, wool, nylon or other sensitive fabrics.

Do not mix with other chemicals. Do not add this product to any dispensing device containing remnants of any other product.
