**PRECAUTIONARY STATEMENTS**

Prevention: Keep container tightly closed. Keep only in original container. Do not breathe fumes, gas, mist, vapors or spray.

Do not get in eyes, on skin, or on clothing. Wash skin thoroughly after handling. Do not eat, drink or smoke when using this product. Use only outdoors or in a well-ventilated area. Avoid release to the environment. Wear protective gloves, protective clothing and eye protection or face protection.

Response/First Aid:

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a doctor or an ophthalmologist.

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately call a doctor.

IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water. Wash contaminated clothing before reuse.

IF INHALED: Remove person to fresh air and keep comfortable for breathing. Immediately call a doctor. Get medical attention if you feel unwell.

Application: Use impermeable gloves, safety glasses and proper ventilation. For renovation, use as is or mix 1:1 with water. For mild cleaning or maintenance programs, use 10oz. per gallon. Spray or pour 6-8 inches from surface or apply with mop. Agitate as needed by wiping or scrubbing. Allow 1-5 minutes reaction time. Wipe or scrub, then remove chemical. Repeat procedure if needed. Neutralize and remove thoroughly by rinsing or wiping.

Do not use on marble or any natural stone, concrete and sensitive surfaces.

Do not mix with other chemicals.
